- 1995 began to purchase/subscribe to electronic information resources

- 2008 Part of the University Administration

# ACQUISITION STRATEGY

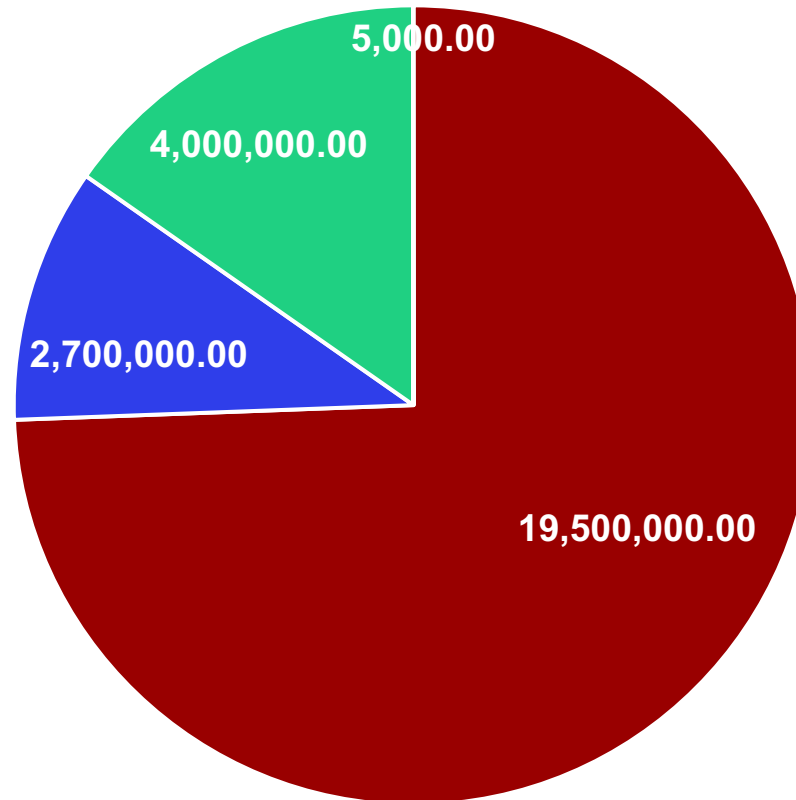
DTU Library will decide - within the set financial frame - whether DTU should own the information resource or whether the material should be obtained through interlibrary collaboration.

We evaluate all proposals for purchase according to the following criteria:

- DTU Library primarily acquires information resources relevant to research and teaching at DTU.
- As a rule, we acquire the material in electronic form for the use of all of DTU.
- In general, DTU Library only acquires recent electronic information resources i.e. published within the last five years. However, evaluating requests on a case-by-case basis, taking both price and demand into consideration, we may make exceptions to this rule.
- DTU Library primarily acquires information resources in English or Danish.

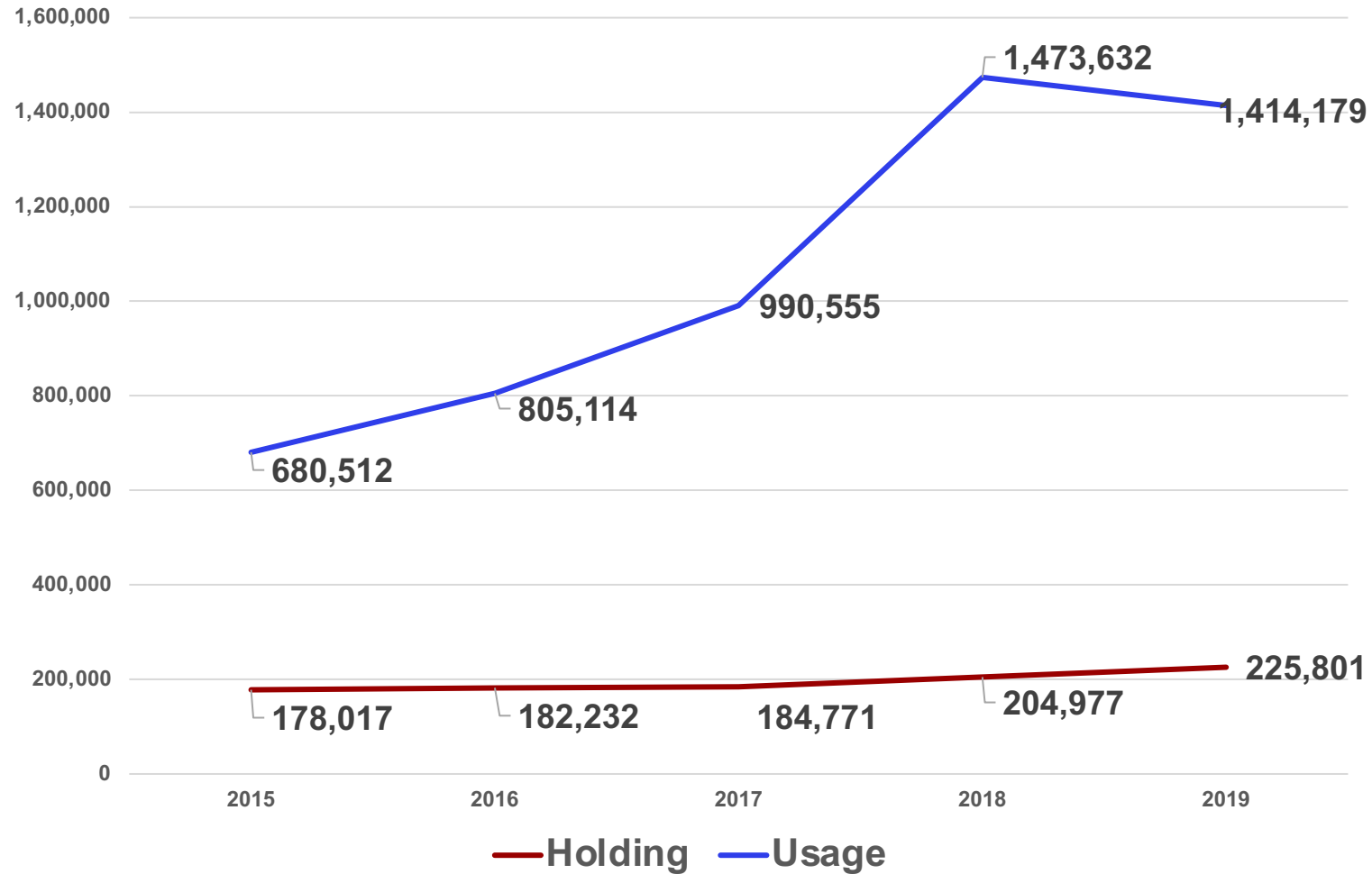


# ACQUISITION BUDGET 2020 (DKK)
