PROBLEM TO BE SOLVED: To provide a multilayer antireflection film achieving low reflectance over a wide band and a wide incident angle range. ; SOLUTION: An antireflection film 10 is composed of a plurality of dielectric layers (11, 12) laminated on the light receiving surface of a photoelectric conversion element 30.
